Sir,

In consideration of the various activities and the duties and responsibilities of Booth Level Officers the matter of revision of the present rates of remuneration for the BLOs as per recommendation of the Election Commission of India has been lying under active consideration of this Department for sometime past.

Now, the undersigned is directed by order of the Governor to say that after careful consideration, the Governor has been pleased to sanction the following rates of lump-sum remuneration for BLOs with effect from 1<sup>st</sup> April, 2010 until further orders.

Rates of Remuneration:

(a) Fixed Component:

- For one Part      Rs. 3000/- per annum if the BLO is in charge of a polling Station.
- For more than one part      Additional amount of Rs. 750/- per annum per part over and above Rs. 3000/- per annum if the BLO is in charge of more than one polling station.

(b) Variable Components

- (i) Rs. 4/- for each PER Entry of photograph made, if PER percentage in the concerned part is less than 90%, out of which Rs. 2/- is to be paid as remuneration to the BLOs. The rest amount of Rs. 2/- will be paid to the other staff of ERO Office on their engagement in the said work.

- (ii) Rs. 5/- for each PER Entry of Photograph made, if PER percentage in concerned part is 90% for above, out of which Rs. 2.50 is to be remuneration to the B.L.Os. The rest amount of Rs. 2.50 will be paid to the other staff of FROs office on their engagement in the said work.

The expenditure will be debitable to the Head of Account "2015-Elections-00-Non Plan-103-Preparation and Printing of Electoral Rolls-001-Parliamentary/Assembly Election (C.I)-V-50-Other Charges" from the current year's budget.
