Sir,

I am directed to refer to this Commission's Order No.392-SEC/1E-64/2009 dated 19.03.2010 regarding identification of electors before the Presiding Officers and to clarify as follows:

a) the electors, who have been issued EPIC for the purpose of establishing their identity, should be allowed to cast their vote only by producing the same. In no circumstances they may be allowed to cast their votes by producing any alternative documents as prescribed by this Commission.

b) in the cases of electors who have been issued EPIC but the EPIC No. has not been reflected in the Electoral Roll, if such electors produce their EPIC for establishing their identity they may be allowed to cast their votes.

c) in the cases of electors, who have not been issued EPIC but the EPIC No. has been reflected in the Electoral Roll, the MERO / AMERO may authorize the Presiding Officer to allow such electors to establish his identity by production of any of the 15(fifteen) documents prescribed by the Commission.

d) the electors, who do not possess any one of the first 14(fourteen) alternative documents mentioned in order No. 392-SEC/1E-64/2009 dated 19.03.2010, will be required to obtain "NON-EPIC" Certificate from the Municipal Returning Officer for production before the Presiding Officer to establish their identity.

e) Student's Identity Card with photograph is an authorized document. Admit Cards with photographs issued by the West Bengal Board of Secondary Education, West Bengal Council of Higher Secondary Education and similar other Boards and Universities shall also be considered as student's Identity Card with photograph.

The Municipal Returning Officers concerned may be instructed to suitably brief the Presiding Officers.
