We have already communicated the fact that no polling station in LWE affected areas will be relocated owing to Maoist problem. However, it is clarified that in the interest of conducting peaceful elections, a number of clusters may have to be formed. A cluster is a suitable place, a high school or such other large location where polling parties of a number of geographically contiguous polling stations will be housed together on P-1 day purely due to safety and strategic reasons. The polling party shall move to the respective booths in the early morning of P day and after the completion of poll, they shall return back to the same cluster. The movement of polling personnel along with polling materials shall then take place from the cluster point to the RC. Needless to say the cluster point needs to be heavily guarded and previously sanitized.

With this objective in mind, BDOs are requested to liaison closely with their respective I/Cs and O/Cs of their police stations and to identify such clusters in the format annexed herewith and forwarded to the respective SDOs. Concerned SDOs shall scrutinize the cluster proposals in close liaison with Addl. SP/SDPO and forwarded to the district by 31<sup>st</sup> January 2011 positively.

SP Paschim Medinipur and SP Jhargram is requested to kindly instruct Addl. SP /SDPOs/ICs/OCs to closely liaison with SDOs and BDOs in this regard.

**This is highly urgent and must be given top most priority.**
