

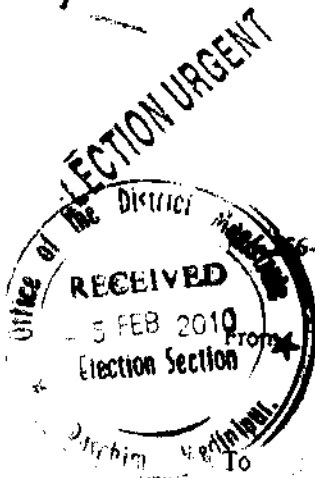

NOTIFICATION

Whereas the State Government, in exercise of the power conferred by Section 8 of the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) has determined under Notification No. 12/MA/0/C-4/1M-5/2004 Pt-II dated the 7th January, 2010, that the number of wards in the Municipal area of the Kharagpur Municipality in the district of Paschim Medinipur hereinafter referred to as the said area shall be 35 (thirty five) wards.

Now, THEREFORE, in exercise of the power conferred by Section 3 of the West Bengal Municipal Elections Act, 1994 (West Ben. Act XXXIV of 1994) and in supersession of all previous notifications in this behalf, the West Bengal State Election Commission, having regard to population, dwelling pattern, geographical conditions and economic considerations hereby divides the said area into the required 35 (thirty five) wards as described in the Table below for the purpose of election of members of the Municipality as aforesaid for the said area.
