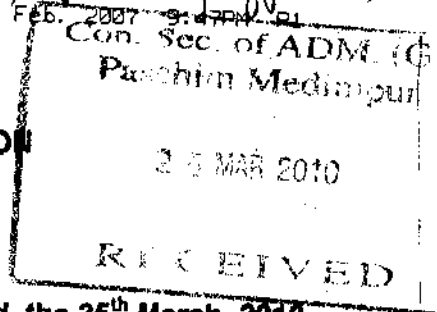

DIRECTION

In continuation of this Commission's Order No.296-SEC/3P-6/2007 dt.03.03.2010 regarding formation of polling parties the Commission hereby directs further that the following points shall have to be considered at the time of formation of polling parties.

- (1) Seniority of officials should be taken into account and it should be ensured that a Senior Official is not put on duty under an officer who is junior to him.
- (2) School teachers should not be posted on polling duty.
- (3) In case where due to non-availability of Government Servants, employees of local bodies namely Gram Panchayat, Panchayat Samiti and Zilla Parishad etc. are to be engaged for polling duties at a polling station, it should be ensured that the Presiding Officer and the first Polling Officer of a Polling Station should not both be the employees of the local authorities.
- (4) The Presiding Officer is required to perform very important functions. He should as far as possible be a senior official not below the rank of U.D. Assistant.
- (5) Have a reserve list of Presiding and Polling Officers for the Municipal Constituencies to deal with emergencies at any of the polling stations in the constituency as well as conducting re-polls, if required, but this should be restricted up to 20% of the total strength of Presiding & Polling Officers under the control of the Municipal Returning Officers.

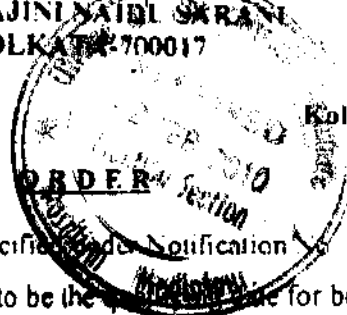

WHEREAS, the Commission has specified under Notification No. W.B. SEC/3E-20/2009 dated the 27th January, 2010 that the 1st January, 2010 to be the date for being registered in the electoral rolls for the purpose of elections to be held in the year 2010 to Municipal Corporations, Municipalities and Notified Areas within the State of West Bengal. and

WHEREAS, Election Commission of India has not yet initiated the process for preparation / revision of electoral rolls with reference to 1st January, 2010 as the qualifying date. for the election of members to the West Bengal Legislative assembly.

NOW, THEREFORE, in exercise of the power conferred by Article 243 ZA of the Constitution of India and the proviso to sub-section (1) of Section 5 of the West Bengal State Election Commission Act, 1994 (West Bengal Act VIII of 1994) and in pursuance of sub-section (1) of Section 20 of the West Bengal Municipal Elections Act, 1994, the State Election Commissioner, West Bengal State Election Commission, hereby orders that the relevant parts of the Electoral Roll published with reference to the 1st day of January, 2009 as the qualifying date (hereinafter referred to as the basic roll), which is in force on the date of this Order for the election of members to the West Bengal Legislative Assembly shall be adopted as the draft electoral roll for the purpose of Municipal General Elections in each of the constituencies of the Municipal Corporation, Municipalities and Notified Areas as mentioned in the schedule below (hereinafter referred to as the said election) and that the Municipal Electoral Registration Officers concerned shall sub-divide the basic roll, as adopted, in such manner or in such part or parts as he may deem expedient for each of the Municipal Constituencies and shall cause publication of the rolls in draft under Rule 8 of the West Bengal Municipal Elections (Registration of Electors) Rules, 1995 on the 15th February, 2010 at the places as mentioned below. The Municipal Electoral Registration Officers concerned shall simultaneously publish Notice in Form 2 prescribed under the said rules fixing the 5th day of March, 2010 as the last date for receipt of claims and objections at the places to be determined by the MERO concerned. Claims and Objections so received are to be disposed of by the 20th March, 2010 following the provisions of the West Bengal Municipal Elections (Registration of Electors) Rules, 1995. The final rolls as prepared following the provisions of rule 21 ibid is to be published on the 5th day of April, 2010 along with Notice in Form 13 at the places as mentioned below. Two copies of each separate part of the draft and the final electoral roll be supplied free of cost to every recognized political party for which a symbol has been exclusively reserved in the State by the Election Commission of India


It may be mentioned here that this Electoral Roll shall be used only for the ensuing Municipal Elections and this will not be applicable to any other elections. This may be clarified to all concerned.



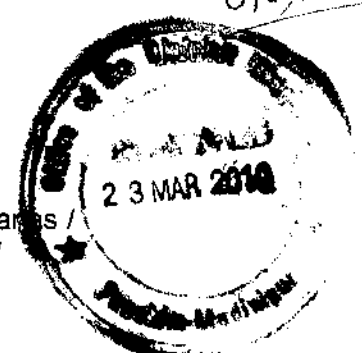
