

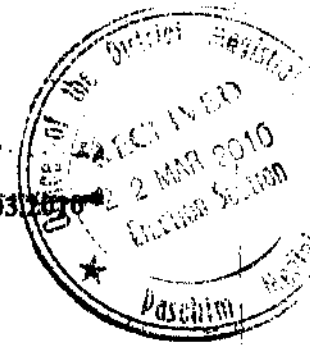

**ORDER**

R-356
23-3-10

WHEREAS Section 65 of the West Bengal Municipal Elections Act, 1994 (West Bengal Act, XXXIV of 1994) provides that, at the time of poll, electors, for the purpose of establishing their identity before the Presiding Officer or a Polling Officer of a polling station, before casting their votes, are required to produce the Electoral Photo Identity Cards (E.P.I.C.) issued in terms of the provisions under the Representation of the People Act, 1951 when such electors of the constituency concerned or the polling station in question have been supplied with the Identity Cards, with photographs attached thereto;

AND

WHEREAS it appears that all electors of the polling stations within the area of the municipality to which elections will be held and polls will be taken in May/June, 2010, have not been provided with the said Identity Cards;

AND

WHEREAS Rule 39H(3) of the West Bengal Municipalities (Conduct of Elections) Rules, 1995 provides that the Presiding Officer or the Polling Officer, as the case may be, is required to be satisfied about the identity of the elector before allowing him to cast his or her vote;

Now, therefore, in supersession of all previous orders in this regard the State Election Commissioner, West Bengal State Election Commission, in exercise of the power conferred by Art. 243ZA of the Constitution of India read with section 5 of the West Bengal State Election Commission Act, 1994 hereby directs that

- A. The electors, who have not been issued with EPIC shall produce, for the purpose of establishing their identity, any one of the following documents before the Presiding Officer or the Polling Officer authorized by him in this behalf :-

LIST OF DOCUMENTS

- (i) Passport.
- (ii) Driving Licence.
- (iii) Income Tax Identity (PAN) Card.



- (iv) Service Identity Card with photograph issued to its employees by State/Central Government, Public Sector Undertakings, Local Bodies or Public Limited Companies.
- (v) Passbook with photographs issued by the Public Sector Banks / Post Office Kissan Passbooks.
- (vi) Students Identity Card with photographs issued by Recognised Educational Institutions.
- (vii) SC/ST/OBC Certificate issued by competent authority.
- (viii) Pension Documents with photographs such as ex-servicemen's Pension Book/Pension Payment Order, Ex-servicemen's Widow/Dependent Certificates, Old Age Pension Order, Widow Pension Order.
- (ix) Railway Identification Cards with photographs.
- (x) Freedom Fighter Identity Cards with photographs.
- (xi) Arms Licenses.
- (xii) Certificate of Physical disability issued by Competent Authority.
- (xiii) Identity Cards issued to Bidi Workers by the Ministry of Labour, Govt. of India.
- (xiv) Photo Passbook for Provident Fund issued to unorganized workers by the Labour Department, Govt. of West Bengal.
- (xv) 'Non EPIC' certificate with photograph issued by Municipal Returning Officer or Assistant Municipal Returning Officer. A specimen copy of such certificate is enclosed.

Note: An elector would be presumed to have not been issued with EPIC when no EPIC number is noted against his name in the Electoral Roll including such electors whose names have been registered in the Municipal Electoral Roll during revision in March/April, 2010. Nevertheless if such elector possesses EPIC he may produce the same to establish his identity.

B. The elector who have been issued with EPIC but are unable to produce the EPIC because of its being lost due to arson, flood, theft or other reason beyond his control shall inform the Municipal Returning Officer along with a copy of the FIR/GD entry lodged by them, atleast 7 days before the date of poll and obtain a certificate from the Municipal Returning Officer and shall produce the aforesaid certificate. The Municipal Returning Officer will issue this certificate in the form, a copy of which is annexed hereto.
